O Lebo stopped by at the start of the BOA meeting just to brief the Assessors about an article that Northfield Historical Commission has submitted to be brought forth to Town Meeting. The Article seeks to have the Northfield Historical Commission included among the list of "Signatories of Local Compliance" and the departments, boards and commissions involved in the building permit process.

"To see if the Town will vote that the Northfield Historical Commission, hereinafter called the Commission, shall be consulted along with the departments, boards and commissions require by the permitting process for land and building projects within the Town. Applicants shall submit to the Commission for review, plans to expand, demolish, alter the street view, and/or change the use of structure build prior to 1900, and projects involving the excavation, alteration, and/or change of use, of project on land larger than 50,000 square feet. The Northfield Historical Commission shall have the option to request additional information about projects described above from the proponents. The Building Commissioner, Board of Health, Planning Boards, Zoning Board of Applies and the Conservation Commission, other relevant boards, and the applicants shall work with the Northfield Historical Commission to develop preservation or mitigation strategies for historical and cultural resources identified during the approval process".
