## o TAX CLASSIFICATION HEARING

- On a motion by Rogers, seconded by Cummings, the Selectboard moved to open the Public Classification Hearing to discuss the allocation of the local property tax levy among the property classes for FY2020
- Rogers read the legal notice: "The Selectboard, in conjunction with members of the Board of Assessors, will hold a joint public hearing on Wednesday, December 11, 2019 at 6:00pm at town hall, 69 Main St., Northfield, MA to determine the percentages of tax levy to be borne by each class of real and personal property for Fiscal Year 2020, per MGL c.40, s. 56, as amended."
- Walker present the classification options
  - Property Values have gone up approximately 5%
  - Proposed Single tax rate of \$16.61 with excess tax levy capacity of \$1,042,946
- There were no written letters or verbal comments regarding this hearing for or against a single tax rate
- On a motion by Cummins, seconded by Rogers, the Selectboard voted unanimously to adopt a uniform tax rate, otherwise known as a single tax rate for all classification for the Fiscal Year 2020
- On a motion by Rogers, seconded by Cummings, the hearing was closed at 6:14pm
- The Selectboard adjourned at 6:14 pm. Assessors remained in session
