3. Building Business

An initial timeline of our plan to restore walls and ceiling in small sitting room upstairs (South Meeting Room):

- a. April 2023: Our Director is contacting conservation companies. Misha is also talking to Williamstown Art, the organization that we used for the Trustees Room. Since it has been many years since they did the last report in 2017 they will have to come out and do another report at the cost of \$980. Misha is working on setting up two additional visits this month with other companies, and will potentially have three others come at a later date.
 - Should we have them do an updated report on the Children's Room? Given the expiration, likely not a good idea.
 - ii. What is our 'up to' amount for these visits? The Trustees make a motion to get additional quotes before we make a determination about spending money on 'Proposals for Treatment' Moved/Seconded/Unanimously Approved
- b. May 2023: Have summer appointments lined up
- c. June/July/August: Appointments from Williamstown Art and one other to receive estimates/reports of work to be done
- d. September/October: Write Grants
- e. November: Submit grant drafts to the Trustees
- f. January: CPA Grant is due
 - i. CPA Notes: requires two different quotes. Tends to be up to \$30K. The cost of the Trustee Room was \$16,942 in 2017. If we exceed the \$30K somehow, we do have funding in our building account.
