### Review and Approval of Minutes:

#### Citizens' Concerns:

Steve Wiggins: Item moved up to assist with his time allotment. Steve initially spoke with Tom and Isaac. The Sewer line comes out of 91 Highland/36 Pine and regularly clogs. State as weekly backups. Tom W has been on site a couple times. The house across Pine Street is on a different line. There has been good progress so far but need a fix.

Thomas Aquinas (TAC) is responsible for about 200 feet of pipe. There is a 6-inch diameter pipe with gravel and dirt coming through it.

Steve – Clay pipe is coming out the house and Steve needs a fix. The Pine St manhole is located on Pine St, below the tennis courts, near the first smaller home on the right.

It is approximately 150-200 feet to come down the road and tie in.

KB – is there another place that is closer or easier to tie into?

DG – Will go site on Friday morning, 2/11, and meet with Steve.

SW - Digging will be messy no matter where they work.

IG - The line is too small for the Commissions camera. Let's table for 1 week.

  DRAFT bylaws. Residential pipe from a house is 4-inch diameter. Commercial (multi res.) is 6-inch
  diameter.
