- Pipe lining has been completed
 - Manhole grouting and sealing completed as well.
- Clearing around manholes and easements when time allows
 - There are some issues with st5ructures on easements/access issues
- Two high flow events.
 - o Greater than 1mgd flow rates
- Flushed dead end lines
- Root control to most of the system
 - o Couple areas left
- Digital flow recorder working properly, finally !
- DO signal is into the building
- Lightening strike shorted VFD for screw pump
 - New VFD installed and working properly
- Some E. Coli issues
 - One high record messes up the monthly average
- Foam issues
 - Common during the summer
- Some plant water lines replaced because of leaks
 - Josh did a nice job
 - o Replacement will continue this winter
- Estimated sludge removal cost has up to about \$26,000 for the year.
- Working with Karen on ARPA requests
- Sewer pipe was exposed on main st where college up in a driveway
 - The lack of berm on the road allows water to run down the driveway and wash out the dirt.
- Letter from 1 Parker Ave was presented by IG.

Abatements:

Billing:

- Quarterly billing statistics to date from Michele Turner. Sanda Contway building is removed.
 Sewer needs to be capped. Steve will follow up with Dennis in Ca. IG needs to witness the capping. The adjustment will be on the next bill. The bills went out on 8/22. The process is pay and abate.

Capital Projects: Pipe relining Status from Isaac

DG asked for an Engineering plan. Steve can do the plans at dig time. The Marsh house is being replumbed. DG is ok with the grade on this work. Add it to bigger paper and print, as built when the job is finished. Steve committed to an end of October completion date. Bore manholes in place. IG will call UG and see how quickly they can make the products. Motion to accept the project by DG, 2nd by TW, All approved.
