Fletcher Sewer and Drain, Sewer Comm, and Engineer, House Contractors, Highway Dept. onsite 9/26/2023 Grades and closing the map loop for future relocation of sewer. Also helps to satisfy part of the consent order.

Option 1 - Hook to a 4-inch pipe in front of 75 Highland.

The 4-inch pipe at 75 Highland and full of roots. Cannot hook another house into a 4" pipe. Waiting on grades from Engineer- Invert = 46.18. DG suggested there is another option, hook to Hubbard's.

Opt 2. 74 to Hubbard's.

Need a 1/8-inch slope for every foot in a 6-inch pipe.

Daniel V - has 1 contractor. Working on price. Norwich Construction for Quote-House front to Highland Ave. TW: 2nd manhole at Hubbard's can wait

Household water line at Hubbard's. Engineer (Eric) will provide regulations on how to safely cross the lines. 30B matrix requirements, \$10,000 > \$35,000 3 calls, If the project is over \$35,000 then we need Quotes in writing.
