MHC suggested cemeteries need a landscape architect. \$5,000-\$30,000 planning grants; \$7,500-\$10,0000 for actual restoration work. 50% match. Due March 23. Can we do this this year? Next year? How much? The one estimate we have is \$1,500 to make a master plan about how to proceed. Discussion of costs and needed work and matching funds. Need Friends of Northfield Old Cemeteries revived to get money and get Kai out there doing the \$1,500 inventory this spring. \$300 our account; \$1,172 in FONOC account; we have \$500 in our yearly budget. Sue will contact the Secretary of State to get FONOC back on track.

strongly states, since there's nothing in it that's legal, it doesn't need to go to Town Council. He
will let us know well in advance when he presents it at the Select Board meeting.
