Reminder of mission statement (Patter Field): The Campus Center-Community Collaborative Committee (CCCCC) was appointed by the Northfield Selectboard to foster communication, promote understanding and collaboration among community members selected by pertinent Town Boards: at-large members of the Northfield community and the owners and representatives of the former Northfield campus (Thomas Aquinas College, the Moody Center). Predicated by the Town's Master Plan, the C5 allows members of the Town to maintain a proactive advisory role in the redevelopment of the campus, encouraging re-use and growth which reflects the historic aspects of the campus, and assuring that the Town's long-term goals are considered in the process.
