Late fees.

The library will also experiment with a "conscience" jar, with that money going

to the Town. We will try it as a "DIY FINE" donation opportunity.

Budget changes.

Deb Kern polled Massachusetts libraries through our listserv and received 30 replies from libraries around the state. The differences range from Greenfield, where the library budget is personnel, materials and line items only related to processing library materials to a number of towns whose utilities and/or building maintenance are paid by various town departments. Consideration of these changes is a balancing act and must be made very carefully. Deb will be meeting with the Town Administrator, Town Accountant and Highway Supervisor next Wednesday morning to get their input. It comes down to saving money versus sharing control of the building. This consideration is prompted by the State Aid requirements and the loss of the accommodations for spending.
