## REMAINING DISCUSSION OF OPERATING BUDGET REQUESTS FOR FY2023 & DECISIONS ON FINCOM RECOMMENDATIONS THEREON

Llamas not present but advised Stearns that she will have a spreadsheet and figures containing all capital plan requests, as well as any income available at the next meeting

The Agiculture Commission did not submit budget; it would be level funded.

The CONSCOM is working with Llamas to get the services needed via the current Boards Clerk; this would eliminate the CONSCOM increase in budget for hardware (laptop) as the Boards Clerk is already provided one.

The Memorial Day account will be level funded

ZBA never submitted a budget request and will be level funded

- Brief discussion on EMS; no concerns with current budget submitted. If EMS should ever regionalize, there is the potential for a different hierarchy
- Brief discussion on Highway capital request of \$200,000 for a truck. There was a bit of a misunderstanding by FINCOM members whether the \$200,000 would be used to purchase a used truck or if a new truck had to be purchased, would \$200,000 be enough; Campbell believed it to be closer to \$300,000 for a new truck.

Brief review of Police Budget. Increase to budgets and the SRO position

Recreation Commission; no increase to budget just a reallocation of funds within the accounts. Also needing a lawn mowing service

Brief review of Sewer budget and capital requests

- The Tech School budget that was presented to the FINCOM was voted on and approved by the Tech **School Committee**
- Treasurer/Tax Collector no change in budget
