# REVIEW AND APPROVAL OF END OF YEAR FUND TRANSFER REQUESTS

- Dickinson Library requested a transfer from Library Salary and Wages to Library Expenses in the amount of \$3,500 to cover May and June expenses that were higher than anticipated (Electrical and Miscellaneous Maintenance expenses)
  - A motion was made by Campbell, seconded by Matteo and <u>VOTED</u> unanimously to approve the transfer in the amount of \$3,500 from Library Salary and Wages to the Library Expense Account.
- O The Selectboard requested a transfer from the Reserve Fund to the Selectboard Other Purchase Services account in the amount of \$9,375 to cover the expense of the Town Administrator Search back in December of 2018.
  - A motion was made by Campbell, seconded by Matteo and <u>VOTED</u> unanimously to support the transfer of \$9,375 from the Reserve Fund to the Selectboard Other Purchase Service account.
  - Selectboard requested a transfer from the Reserve Fund to the Selectboard Other Purchase Services account in the amount of \$975.00 to cover the costs for the services of FRCOG for the bidding of the cell tower easement.
    - A motion was made by Campbell, seconded by Matteo and <u>VOTED</u> unanimously to support the transfer from the Reserve Fund to the Selectboard Other Purchase Services in the amount of \$975 to cover the cost of the FRCOG's bidding of services pertaining to the cell tower.
  - O July 15 is the deadline for transfer requests

## REVIEW OF WARRANT FOR SPECIAL TOWN MEETING

- A motion was made by Porada, seconded by Matteo and <u>VOTED</u> unanimously to recommend article 3, a \$141.00 increase to the Recreation Commission director wages to cover the COLA.
- A motion was made by Porada, seconded by Matteo and <u>VOTED</u> unanimously to recommend article 4; having a limit on revolving funds for FY20
- Article 2 is the PVRS Budget. The (4) towns wanted to have any savings in the closing of a school(s) to be given back via assessment to the town. This does not appear to have happened. June 10 is the next 4 Town meeting where this will be discussed.
- Article 5 is to create a committee and appoint members to the Regional School District Planning Committee.
  - A motion was made by Campbell, seconded by Matteo and <u>VOTED</u> unanimously to support article 5

  - Clear Gov meeting is scheduled with the accountant to start this program up
- o Gilfeather-Girton provided month end balances through the end of April

  - Northfield FINCOM members replied to letter as Neutral/Unsure due to time restraints

Bore holes are done, the environment reports should be returned soon and the group is ultimately trying to move forward.

- Matteo (Community Preservation Committee): no new meetings attended
- Matteo (H.E.A.R.T Committee): Putting together report for state for grant and giving the Selectboard a shorter version of the report. One more meeting then group will disband
