The FINCOM meeting was called to order at 6:00 pm by Stearns

REVIEW AND APPROVAL OF MINUTES

- The minutes from the May 12, 2020 meeting were reviewed
 - A motion was made by Campbell, seconded by Spanbauer and <u>VOTED</u> unanimously to accept the May 12th, 2020 minutes as presented. ROLL CALL IN FAVOR VOTES: Stearns, Campbell, Porada, Kaczenski, Matteo and Spanbauer
- UPDATE ON DISCUSSIONS RE: TOWN MEETING(S) WITH MODERATOR AND WITH SELECTBOARD
 - The Selectboard at their last meeting, voted to have the Annual Town Meeting and the Special Town Meeting on the same night; June 29th, 2020
 - O Still waiting on legislation approval, but the Caucus may be handled differently.

UPDATE ON PVRS BUDGET/ASSESSMENT

5/19/2020 the budget subcommittee met and recommended to reduce the budget to_be brought forth the school committee on 5/20/2020. Due to the longer than expected school committee meeting, it was voted to revisit the budget recommendation at their next meeting

AMOUNT OF FREE CASH AND REVIEW OF TOTAL FUNDING AVAILABLE FOR FY21

- Llamas reported on Free Cash
 - Highway/Chapter 90 and Green Communities didn't have reports turned in by deadline of June 30 to state. Money will show up next year
 - Enterprise funds certified

REVIEW DECISIONS ON RECOMMENDATIONS FOR FY21 BUDGET ITEMS INCLUDING FUNDING

- OPEB and Stabilization discussion. \$75,000 from free cash to OPEB and \$100,000 from raise and appropriate for stabilization
- o Llamas completed spread sheet with all the pay grades, COLA's and Steps
- Llamas advised FINCOM that the COA may have a budget request change, however nothing has been submitted. Llamas to confirm with COA and advise if in fact there is a change to budget request that it be submitted asap.

REVIEW DECISIONS ON RECOMMENDATIONS FOR FY21 ARTICLES INCLUDING FUNDING

- L'Etoile discussed concerns about Town Meeting and having everything on one warrant. There is more flexibility with the two meetings (Annual and Special)
- L'Etoile suggested appropriately grouping certain articles within (1) motion. This would shorten the
 meeting; individuals still have option to pull out an article if they so choose.
 - Campbell suggested that L'Etoile give an explanation at the beginning of Town Meeting to this method
- o Discussion on article 10; library door.

- O Llamas to regroup articles and discuss with L'Etoile for final review
- o Omnibus
 - A motion was made by Spanbauer, seconded by Campbell and <u>VOTED</u> unanimously that the FINCOM support the omnibus as presented with the exception that it is subject to change should the Council on Aging put in a change. In Favor Votes: Stearns, Campbell, Matteo, Kaczenski, Porada and Spanbauer
- Articles on Warrant for Annual Town Meeting and Special Town Meeting
 - Well article removed from warrant
 - Preston Memorial was not recommended by the FINCOM however the Selectboard voted in favor of it and it will be on warrant
 - Right of Way (Schell Bridge) article removed from warrant
 - A motion was made by Campbell, seconded by Matteo and <u>VOTED</u> unanimously to support the articles as presented for both meetings. In Favor Votes: Stearns, Campbell, Matteo, Kaczenski, Porada and Spanbauer
- O Tax rate with the articles/budget as is estimates a tax rate of \$16.74, however should the school budget change, that will change the tax rate (.21 for every 100,000).

 - o none

 - o Will only need to meet before Town Meeting, unless the COA presents a change request
