APPOINTMENT TO ARPA (FEDERAL RECOVERY ACT) COMMITTEE

- O Llamas updated on the ARPA, it will come in two branches; 50% in the next 30 days and the other 50% within 1 year. A total of \$860,000. Llamas wants a small advisory group to work together to help determine how to spend this money. Llamas is looking for a FINCOM rep.
 - A motion was made by Matteo, seconded by Porada and <u>VOTED</u> unanimously to have Dan Campbell be the FINCOM representative for the ARPA advisory group. Campbell accepted.

REVIEW OF MONTHLY BALANCE REPORT

- Town Hall sewer use line account is negative due to the changing in billing methods by the sewer commission.
- Snow removal account in the negative right now, however the overall highway budget should be able to cover this.
