## **Old Business and Updates**

- -First Light and FERC: A number of test pits came up with artifacts. Most be tested next spring. Joe will call the chief archaeologist Walters for an update. Tribes have been out there. All the archaeologists are out and might not start the intensive this fall.
- **-Discussion of handout Lis sent re:** handling of artifacts on private land. Triggered by 106 or human remains. If either are absent, then have to go to private property state laws, which still gives the private landowner ownership.
- -House Bill 2929: Joe will check in with Paul Mark on how this is going. Nothing will happen until after Jan 1, next legislative session.

## **Continuing Business**

**-Item for Town Meeting postponed from May 2018:** Carol reported on a phone conversation with Jeff Blake (Northfield Town Lawyer); he recommended that we ask the Selectboard to help us as a policy not a bylaw. Carol explained to him that NHC is not just about architecture but about archaeology. This. might be a first step to build trust. To take the edge off antagonistic conversations, NHC will emphasize

"cultural, historical, and agricultural heritage of this community." NHC Commissioners are working independently on a policy during December. NHC does not know where to get help now – except that which the Town Lawyer provided - hopes for new Town Administrator. Tabled to January.
