• Scheduled Appointments

- 6:00 pm Northeast Paving storage tank license amendment Hearing
 - Notice read: A Public Hearing will be held at Northfield Town Hall, 69 Main Street, Northfield, MA in the Select Board meeting room on February 21, 2023 at 6pm to consider an application for license amendment (FPA-2)
 - from Eurovia Atlantic Coast LLC dba Northeast Paving at 216 Mt. Hermon Station Rd, Northfield, MA requesting approval for increased storage capacity of liquid asphalt cement
 - Motion by Meisner, seconded by Cummings the Select Board voted unanimously to enter into a hearing for Northeast Paving's request for license amendment
 - Northeast Paving removing 40-year-old 35,000-gallon tank and requesting to replace with two 30,000gallon tanks
 - Chief Dunnell has signed off on the request pending the engineer and state fire marshal approval. He had
 no concerns and reported the tank was well maintained
 - Julie Simons is managing the project and is working with Chief Dunnell, Tighe & Bond to follow state and local regulations. Much of the work will be done by Northeast Paving
 - Motion by Meisner, seconded by Boudreau the Select Board voted to grant the amended license located at 216 Mt. Hermon Station Rd Map 26 Lot C2 Map 28 Lot A2for license amendment FPA-2 for Northeast Paving pending approval by the state fire marshal
 - Motion by Cummings, seconded by Boudreau the Select Board voted to close the hearing at 6:16 pm
- o Request to extend term of Fire Chief
 - Chief Dunnell requested a five year extension to see the Emergency Services facility through to completion
 - The article request is worded "up to five years"
 - If the facility is completed before the five-year request, he will step down as chief
 - Feedback from Senator Comerford, Representative Whipp and the town's insurance office has been requested
- FRCOG DLTA presentation on re-use of the current fire house
 - Jessica Atwood, Economic Development Program Manager for the Franklin Regional Council of Government gave a PowerPoint presentation on potential re-use of the current fire station. The presentation will be posted on the town website
 - Community input will be scheduled through the One-Stop program at a future date. Input from this
 meeting will be provided to the consultants who will develop ideas and present at a second community
 meeting. Final design concept will be presented to the Select Board
- Appointment of Wastewater part time operator
 - The Sewer Commission was not able to attend but requested the Select Board appoint Mark DePonte as a part-time operator. Boudreau reported DePonte was a wastewater retiree with an extensive background of qualifications. DePonte will come in for a meet and greet at a later date.
