Business

- Campus Center Community Collaborative Committee update
 - Cummings discussed the withdrawal of the Moody Center from the collaborative and proposed the committee pause until after the reorganization of the Select Board in May to discuss the future of the committee.
- Emergency Services Facility Update
 - Cummings reported the project progress and the budget coming in at or below projection
 - Conservation Commission DRAFT Order of Resource Area Delineation (ORAD) for the Study Area portion
 of the proposed Northfield Public Safety Complex property at 0 Highland Avenue was approved during
 their public meeting of March 15, 2023. Dates need to be finalized and for the ORAD to be signed.
 - Planning Board Site Review is March 22.
 - ZBA Variance hearing is March 28th.
 - General Contractor Bids are out and due back on April 12th
 - Council on Aging is having a coffee hour with the Operations Project Manager and Chief Dunnell on April 4th at 10:30.
 - Special Town Meeting is on April 19th. There will be an information session prior to the vote.
 - Llamas suggested the Select Board meet with the Finance Committee to discuss debt exclusion and other options
- Review of draft Special Town Meeting Warrant
 - The meeting will be opened, adjourn for a recess and do a presentation on the project, funding, etc.
 before reconvening to vote on the articles
 - Article 1 to pay for continuing contracts with OPM, designer, temporary borrowing costs if the project is approved.
 - Article 2 to approve funding of the project this will have a real number as the General Contractor bids will be opened the week prior.
 - A 2/3 vote will be required
 - Warrant to be finalized at next Select Board meeting
- FY 24 Budget update
 - Currently the budget stands at \$11,079,662.
 - This is \$973,741 less than last year
 - Adding in revenue sources, includes enterprise revenue. Those costs only go to the respective
 user fees. The total amount to be raised is estimated at \$8,613,477. This is \$230,960 less on the
 tax rate than last year.
 - Revenue sources are estimated at this time:
 - Unrestricted General Government Funding the only budget out is the Governors usually the lowest of any funding received.
 - Local receipts are estimated each year. This is money taken in for excise taxes, fees, etc.
 Estimates are conservatively to take in more than estimated. Estimating \$425,000. Last year received \$654,000. Estimated tax rate is always slightly higher until actual numbers are received.
