 - Location options included the Northfield Drive-In providing holding in an area located in the states of Massachusetts and New Hampshire is viable.
 - A virtual version was discussed. Resident ideas are welcome.
 - On a motion by Meisner, seconded by Cummings the Board voted that subject to MGL c.39 sec.9, the Selectboard of the Town of Northfield postpone Annual Town meeting from May 4, 2020 to June 29, 2020; motion amended to June 22, 2020. Support of the amended date: Meisner and Cummings yes, Rogers no.
- Electric Aggregation Discussion with Denise Allard, Mark Capadonna of Colonial Power and Susan O'Connor, Energy Committee Chair(remote)
 - The DPU order was approved
 - RFP will be issued this week for an August 2020 start
 - May 13 will be a dry run on pricing
 - May 20 will go live with pricing with an actionable contract to sign. Pricing will have to be better than
 Eversource or will not go forward
 - Renewable sources available. Looking to support local green supplier.
 - Need vote on signatory prior to May 20. Llamas or Selectboard must be present.
