    - Design of railing
      - o Difference discussed; the Advisory recommended the version without the second railing
    - Color
      - The Advisory preferred natural color to blend w/ landscape: Bronze
    - Info panel:
      - The Advisory chose to reference pre-colonial residents; historical uses before the Schell Bridge was built; design features of original bridge
      - Emphasize the process replacing bridge to the new structure
      - Discussion to adjust the contribution of work the Friends of Schell Bridge contributed.
         Current version downplays FoSB role.
    - Name
      - Department of Conservation and Recreation suggested The Schell Bridge Greenway; the Advisory initially agreed then suggested Northfield Schell Bridge Greenway.
      - Native inclusion suggested: to give historical reference add Pauchaug (translation-at the crossing/at the clear place) to Schell; colonial settlers called area Pauchaug;
      - To connect all recreational dots: Pauchaug-Schell Greenway Bridge or Pauchaug-Schell Bridge Greenway
