    - Noise bylaw from the Town General Bylaws read
    - MA General Law Chapter 138, Liquor license holder exception clarified
    - Discussion on extreme motor vehicle acceleration
    - Letters from Kelly Gowan, Glenwood Ave. and Caitlin Sheridan, Highland Ave. read regarding noise events at Northfield Golf Course
    - Options for measuring noise levels and alternate solutions considered. Two written complaints received; one complaint received by the police department
    - Golf Course owner Ed Snow addressed the board and said he was trying to work through the problems by
      physically modifying the area and change venue time length to reduce the noise from events. Residents
      with complaints can contact Mr. Snow directly or the police department
    - The situation will be monitored
    - Joanne and Bill McGee of Main St. requested the Selectboard install signs prohibiting trucks from using air/jake brakes on Main St., Route 10 and Route 142
    - Requests in the past to MassDOT resulted in the state citing safety issues for the use of the air brakes and refusal to provide signage
    - Llamas to reach out to MassDOT again and asked for the emails the McGee's collected
    - Changes to the noise bylaw included striking the section on extreme acceleration and replacing with "noise and include air/jake brake language. Llamas to research language from other towns

- Changing the bylaw time of 11:00 pm to 10:00 pm to be discussed at a later date
- Mosquito Control Update
  - Jacque apprised the board of the latest information on mosquito spraying citing the article in The Recorder by Senator Comerford. The article summarizes the actions taken by the state since last summer. Jacque spoke to residents John Schuster and Martha Rullman who had expressed concerns on the decision to not opt-out of spraying.
  - The Selectboard members reiterated their concerns with spraying & their interest in addressing any budgetary concerns with respect to mosquito control at the Special Town Meeting, anticipated this fall
  - The Board of Health is discussing the topic with member Karen Boudreau focusing on health indications
  - Gathering information from area towns may take 2-3 months.
  - The state task force is expected to publish their findings later this summer.
  - Jacque to continue communications with the Board of Health and to bring the topic of impact to small towns to the FRCOG Executive Council. She will continue to update the Selectboard as information becomes available over the next 2-3 months.
    - Selectboard member Bowen left the room at 7:22 pm and returned at 7:23pm.

    - Motion by Bowen, seconded by Cummings the board voted to appoint Cate Woolner and Heather Tower as the community members for the Police Screening Committee ; Cameron Kennedy, Skip Dunnell, Heath Cummings, Mary Bowen and Melissa Gamache to complete the Police Screening Committee
  - Llamas has solicited four consulting agencies

- Application reviewed with qualifications
- Has signed up for sexual assault investigation training

- Explained supervision experience, organization methods and reported the department moral was good and working on the transition
- Two years' experience as sergeant; full time status since November 2017; has current chief's support
- Fills in current chief's position when he is out on vacation, sick time. Continues to take training classes; trained in administrative duties when promoted to sergeant. Wants to stay in Northfield, has declined offers from other town departments
- Motion by Cummings, seconded by Boudreau the board voted to appoint Alex Pirozhkov as Acting Police Chief until hiring a full time Chief starting July 8, 2021;grade 14 step 2; \$34.68/hr. Vote:4 yes, 1 no. Passed.
