The poles to be set are number 24/11 and 24/14 will be set approximately 10' West of HSE number 37's driveway and approximately 25' from the edge of driveway across the street. 24/11 will be set to the edge of the new shared used path in line with the existing R.O.W pole line. Both poles will have down guys and 14: anchors and only be used for Verizon at this time. The (4) manholes proposed are number 24/11 U, 24/12 U, 24/13 U and 24/14 U. All will be within the new shared
