DIRECTOR'S REPORT

Change to Job Description. The current documented job description for our library director position reads as follows: Education and Experience: Must have a Master's degree in Library Science; five to seven (5-7) years of library administration and supervisory experience; or an equivalent combination of education, training and experience.

As discussed during our last meeting and via email, the ad was adjusted to be in line with what libraries, advertising similar positions, requested. The job description may have been written by the company that was working on updating all of the job descriptions in town, and is not appropriate for a library of our size. The Trustees would like to update the job description to what the ad read: <u>MLS preferred and three years' experience in a public library, or an equivalent combination of education and experience will be considered.</u> Moved/Seconded/Unanimously Approved
