- New Business
 - Town Administrator Evaluation review

 - handling of difficult negotiations and complaints

 - Mixed review on preparation of the warrant. The appearance of the warrant was satisfactory but members requested the warrant to be available sooner before they have to sign to review thoroughly.

 - Requested improvement in the time frame for the development of job descriptions.
 - Special projects, the annual budget items were not applicable for review at this time.

 - Spanbauer: satisfactory; improvement needed; not stepping up to level but can be achieved
 - Blyth: satisfactory; knowledge of policy and finance; people communications needs improvement; improvement needed in providing materials the Selectboard needs to review
 - o Future Plans
 - The Chair requested Morales submit a list of short and long term goals
 - Mend fences
 - Next review to be scheduled in July
