- o Well Article (BOH); NOT RECOMMENDING
- O Town Hall security (door locks) there is a grant helping with the cost of this project
- Llamas to speak with Deb Kern at the Dickinson Library about her article request for the door opener, to get additional information; NOT RECOMMENDING at this\_time.
- FINCOM members agreed to support a revolving fund up to \$10,000 for inspections, Llamas will adjust
- Car Charging Station; the remaining funds from the Town Hall Electrical Upgrade project could support this article
- Discussion on the Right of Way article for the Schell Bridge project; NOT RECOMMENDING at this
  time. Suggest that Selectboard could remove from Warrant.
- O Discussion on putting money into OPEB vs. Stabilization; One or the other or both
- The Community Preservation Articles should be supported as they are already funded, no additional money needed.
- o Preston Memorial; NOT RECOMMENDING

  - Governor is holding a conference on 5/18/2020 to advise of the new opening phases and guideline
  - Llamas is holding a department head meeting on 5/19/2020

  - FINCOM to meet 5/26/2020
- Matteo asked, going back to the discussion of the COLA percentage of 1.6%, could it be brought up to 1.7 (to match the Police Union contract minimum). Llamas didn't know what the exact cost would be to increase it .10%, but thought it to be a couple thousand dollars. Stearns felt there wouldn't be justification to increase it to 1.7% whereas the 1.6% is based on the Social Security increase. No further discussion.
