- 3. The Town of Northfield is going to file for Intervener Status. Lisa is working on the feasibility of the NHC to also file as Interveners. MOTION: "If it is legal and desirable, the NHC will file for Intervener Status with FERC concerning the TGP Pipeline." M: Carol, S: Bob, unanimous.
