## First Light and FERC:

NHC received copies of thank-you letters to Senators Markey and Warren and Congressman McGovern. It makes us wonder what they "said" to FERC. Carol will seek answers. To update newcomers Joe described the process and concerns NHC has discussed as the potentially fifty-year decision is made concerning relicensing of First Light projects on the Connecticut River. NHC will continue to monitor actions. Will there be a Stakeholders Meeting?

MA House Bill 2929 Joe explains history, It seems like the need and interest remain but action not happening in this session.

Llewellyn Property There are continuing questions about wetlands and sensitivity of the property with respect to the proposed solar farm.

Sensitivity Map Confusion over sensitivity map giving statutory authority continues. Carol will check in with Town Attorney Jeff Blake and Town Administrator Andrea Llamas on verification of map authority and next steps to officially implement it.
