Motion by Spanbauer, seconded by Porada to rescind the Finance Committee's previous capitalization article and instead propose \$400,000 to the Emergency Services Building and \$600,000 from the capital stabilization fund to the Emergency Services Building. Roll call vote Spanbauer aye; Matteo aye; Campbell aye; Kaczenski aye; Stearns aye

Jacque had question on the Room Occupancy Tax article and the Finance Committees' opinion Information the same as last year. Finance Committee recommending this article

Stearns stated that the Finance Committee is recommending everything on omnibus except for the school budget and the Selectboard stipend increase request.

Not recommending the school budget because they did not have the budget until this morning Discussion on the Finance Committee position of not supporting the request for the stipend increase for the Select Board

Stearns gave a brief history on how the town came to have first, an Administrative Assistant, then the role of the Town Administrator. The increase to five members of the Select Board was for the purpose of lightening the workload of members.

The Finance Committee could not justify the increase

Water District article The Finance Committee has no position on the non-money article

Cost of living increase (COLA)

The Finance Committee recommends a 6% increase for employees and stipend recipients Article 10 Sewer Project Repaving the access road for \$20,000 to the plant is recommended by the Finance Committee

Pioneer Valley Regional School District Budget

The PVRS budget is about a 2% increase

Cummings concerned about the specific increases in the budget.

Llamas said the school budget needs to pass in its entirety or not at all

Cummings would like more information from the school committee to clarify some of the proposed increases/changes and would like more involvement and collaboration between the Select Board, Finance Committee and School Committee to show solidarity.

Llamas stated that when putting together the budget calendar in November, she will aim to have a meeting with the PVRSD school committee.

motion by Matteo, seconded by Campbell, and the Finance Committee voted unanimously to accept the PVRS budget figure as presented to be included in the omnibus

Motion by Jacque, seconded by Boudreau the Select Board voted to adjourn at 7:15pm The Finance Committee continued their meeting
