- Regional Ambulance Service
 - Bernardston Selectboard members Brian Keir, Chair, Stan Garland and Bob Raymond with Bernardston Fire Chief Peter Shedd joined the Northfield Selectboard for a presentation by EMS Chief Mark Fortier to propose a regional ambulance service.
 - Dedicated staffing would be needed with the increase in call volume which would in turn pay for staffing.
 - Service could start immediately according to Chief Fortier. Fortier and Shedd to put together a business plan.
 - Bernardston Selectboard was amenable to the idea if favorable to the Bernardston Fire Department
 - When asked about the level of service, if a substation in Bernardston was considered and if there were any downsides to the plan, Chief Fortier's opinion was that the level of service would be the same. The current building is a rental and if something in between were available it would be considered. He saw no downside to the plan.
 - Additional funding would be required to scale up staffing.
 - Schedule and funding for replacing ambulances is in place.
 - No funding from Bernardston is planned at this time. May need to be addressed at a later date.
 - Municipal agreement will be needed. The Bernardston Selectboard agreed to an independent study being done.
