Business

- SBA Cell Tower Easement Agreement
 - On a motion by Meisner, seconded by Rogers the board voted to accept and sign the SBA Cell Tower Agreement
- East Northfield Water District rate hikes explanation
 - John Alden, president of the East Northfield Water Co. stated he receives no compensation and is no longer employed by Northfield Mount Hermon. He has been president of the ENWCo since 2017.
 - Rate increase is due to loss of testing waiver and rising capital costs. The company is reaching out to the state for financial help.
 - First rate increase, April 2020 at 73.6%. Second rate increase on top of new base, 42.4% in April 2021. The rate increase is not related to the infrastructure issues.
 - Northfield Mount Hermon owns the property. The water company has little interaction with the school
 - Thomas Aquinas is paying into the water company. Revenue from the college and Moody Center does not equate the revenue from when NMH was using the campus.
- Letter to Senator Comerford and Representative Mark for Special legislation to formalize the name change of the Board of Selectmen to Selectboard and increase the size of the Board of Selectmen from three to five members per the May 6, 2019 Town Meeting approved Article 33 by majority vote.
