Meeting was called to order at 6:00 pm

#### • Citizens' concerns

- Bill Kilpatrick: visibility better for signs on Gulf Rd; need more Gulf Rd intersection signs; requested sign-up for CodeRed reverse 911 notification
- o Joanne Coutu: condition of Gulf Rd. pavement; Gulf Rd. truck exclusion signs are small
- o Bill & Joanne McGee: Verbal and written complaint about truck engine brakes. Request for signage banning use.
  - Llamas to contact MassDOT
- Suzanne Handren: Proud of police department's handling of recent situation. Work needed to create safe & secure work area for department.

## Review and Approval of Warrants

- 8/12/19 Vendor warrant of \$990,635.77
- 8/ 20/19 Vendor warrant of \$28,323.93
  - On a motion by Meisner, seconded by Rogers the board voted to approve the warrants as written.

#### Business

- Police After Action Discussion Chief Leighton
  - Chief Leighton gave an account of events on August 9, 2019 from 3pm until arrestee apprehended at approximately 9pm.
  - Meisner asked questions about procedure, video options in the department, dispatch of area police departments and what improvements were needed
  - Leighton responded the department space is unsuitable and does not have enough safety features.
     Cameras would not have been beneficial to the situation. Response of area departments would not be under his control. New police facility is needed with more space and security.
  - Police Department was not used for staging due to back area in use for an event causing a lack of space for parking.
  - Cummings would like to meet with Chief Leighton to discuss a public safety building and stated as a former officer the Northfield booking room is one of the worst.
  - Emergency call list to be provided
  - Bernard Porada commented as a former law enforcement officer, a member of the Emergency Services
     Facility Committee and Finance Committee member, the police department conditions are not acceptable
     and the town needs to provide a facility for all safety personnel.
- Sign Agreement with Franklin County Sheriff's Office Regional Dog Control Services
  - \$500 yearly fee with a three year commitment
  - On a motion by Meisner, seconded by Cummings the board voted to enter into agreement on August 26, 2019 with the Franklin County Sheriff's Office for the Regional Dog Control Services with and agreement period of July 1, 2019 through June 30, 2020 for this municipality.
- Planning Board Resignation
  - Richard Fitzgerald formerly resigned from the Planning Board effective immediately
  - On a motion by Meisner, seconded by Rogers the board voted to accept the resignation of Richard Fitzgerald from the Northfield Planning Board.
- Draft Time off Request Form
  - Llamas reviewed the process.
  - Selectboard would be aware of department heads on leave
  - The board agreed to initiate the form
