- POLE HEARING: HOLTON ST.
 - Open Hearing- Meisner opened the hearing and read the public notice:
 Under the provisions of Chapter 166 of General Laws and any additions thereto, or amendments thereof, the Selectboard will hold a Public Hearing on September 23, 2019 at 6:00 pm on the petition of Western Massachusetts Electric Company to relocate joint owned pole on northerly side of Holton St. 15' east of existing location to allow room for DPW to dig the area as well as to move a transformer from an environmentally sensative area. The hearing will be held at the Northfield Town Hall, 69 Main Street, Northfield, MA 01360.Alexander R. Meisner Selectboard Chair
 - Discussion with Eversource rep/Public Comment
 - Nick Langone of Eversource gave a brief explanation for moving the pole citing the area as environmentally sensitive and in the way of the current construction project.
 - Nancy Champoux of Holton St. asked about the transformer in front of her residence. Langone explained it was a different type of transformer that services the entire area. The transformer on the pole being moved is not for that purpose. Tom Walker explained the pole in question was installed after a hearing about five years ago.
 - Meisner read the conditions listed
 - On a motion by Meisner, seconded by Cummings the board voted to accept the project involving the pole on Holton St with Eversource.
 - Hearing was closed at 6:09 pm
