The Finance Committee and Selectboard called to order and convened at 6:00 pm.

- Discuss and decide on recommendation for FY'21 PVRSD Operating Budget for further discussion with representatives of Bernardston, Leyden & Warwick
 - o Surplus of \$500,000.
 - o Both boards agreed to hold steady, no increase
 - o Finance Committee voted to recommend the budget remain the same
 - Motion by Rogers, seconded by Cummings the Selectboard voted to recommend the budget remain the same.
 - o Stearns to meet with participating town finance committees to relay decision
- Discuss with Town Administrator a Risk Management Grant Application and the cost of the security upgrades that are being considered for the Town Hall including a decision as to source of funding needed above and beyond the grant
 - Llamas has applied for \$10,000 grant for security changes to Town Hall and suggested moving excess money from electrical upgrade to help with costs. Quote came in at \$19,000
 - Finance Committee supported the project
- Discuss with Town Administrator the possibility of building a desk for the Selectboard in the Selectboard office and, if recommending, decide on funding source.
 - Llamas explained the project for Mass Core to build a table at a cost of \$3,500. Looking for input.
 - o Group discussed adding a table for attendees across the front of the curved table.

 - Auditor will attend Selectboard meeting

 - Rogers, stating as a disclaimer, that she is not involved with the study the FRCOG is doing on regionalizing ambulance service but wanted to group to know it was ongoing.

 - Conservation Commissions in Northfield and Bernardston interested in consultant services
 - Llamas recommended a revolving fund
