- o Tom Walker Road Discussion
 - Walker explained the complications of the warming and cooling weather conditions affecting the roads, specifically the dirt roads in town. Measures taken to keep dirt roads clear of snow and ice differ from asphalt maintenance. Some of the dirt roads are not frozen. Repairs can't be made during the winter months. Sand/salt mixture can't be used on dirt.
 - Average cost is one million dollars per mile. Costs associated with road improvements and paving dirt roads include surveying, land takings, tree removal, and ledge blasting. Four Mile Brook and Orange Rd are the longest dirt roads.
 - Surveying and engineering to be done before actual work can begin. An annual article could be on town meeting warrant.
 - Summer plans: South Mountain Rd & Moody St culverts; grading, sweeping; head wall & box culvert repair; Gulf Rd guardrail and tree work
 - Last year's micro pavement work will be assessed
 - Department is down one truck
 - Walker would like an additional full-time staff member
