 - Motion by Meisner, seconded by Cummings the Board voted to waive the payment of interest and penalties in the event of late payment of excise tax, real and personal property tax, and the annual sewer use charges added to a tax for any payment with a due date on or after March 10, 2020 and made after its respective due date before June 30, 2020. - Vote to extend the date to file for exemptions
 - Motion by Meisner, seconded by Cummings the Board voted to extend the due date for applications for exemption of taxes from April 1, 2020 to June 1, 2020 (NOTE: no later than June 1, 2020; also per DOR this extension will automatically apply to deferrals under G.L.c. 59, s. 5[18A] and [41A], residential exemptions under G.L. c. 59, s. 5C, and small commercial exemptions under GL. C. 59, s. 5I.) Roll call vote: Meisner yes, Cummings yes, Rogers yes.
