- Vote signatory of electrical aggregation
  - Representative to accept executable pricing on May 20
  - Motion by Meisner, seconded by Cummings the board voted to appoint Andrea Llamas, Town Administrator as electrical aggregation signatory on behalf of town
- Cooperative Public Health Service Agreement Nursing Program FRCOG
  - Request from the Board of Health to participate in the regional nursing program
  - Based on assessment, article required for vote at town meeting. Supported by Finance Committee to include in the budget
  - Yearly fee is \$14,800 with \$7,200 paid by grant
  - Rogers disclosed interaction with the service at the FRCOG but does not financially benefit her
    job/department. The service has been well received and was recommended.
  - Once joined the town becomes part of the oversight board for development of the program
  - There is no impact to current health insurance provision. It is a nursing consultant program
  - On a motion by Meisner, seconded by Cummings the board voted to enter into agreement between the Town of Northfield and Franklin Regional Council of Government for the

- Eversource Electrical Vehicle Charger Site Host Agreement
  - Agreement with Eversource to bring the power to the charger at Eversource's expense.
  - Town must purchase the charger. Llamas has identified funding from the Town Hall Electrical project. Project will be expandable in the future
  - Llamas has solicited quotes for units and service.
  - On a motion by Meisner, seconded by Cummings to enter into a site host agreement between the Town of Northfield and Eversource Energy with an effective date May 11, 2020
- o Formal Acknowledgment of Notice of Intent; Jared & Tammy Gibson; 80 West Rd
  - Letter of acknowledgment read
  - Forestry land to be removed from Chapter 61. Unbuildable
  - Committees to be notified
  - On a motion by Meisner, seconded by Cummings the board voted to acknowledge the notice of intent to remove a portion of land from chapter 61, forestry, 3.2 acres on West St.
- Schell Bridge Update Town Meeting Article
  - Town is responsible for Right of Ways, possible long and short-term easements
  - Article gives the town authorization to work on the easements
  - Plans from MassDoT has identified properties impacted
  - Town needs to plan how to pay for the easements and engineering
- Date for Town Meeting
  - Town Clerk, Moderator and Finance Committee raised concerns moving date to June 22.
  - State recommending all towns apply for 1/12<sup>th</sup> budget plan in case Town Meeting budget is not passed before July 1
  - On a motion by Meisner, seconded by Cummings the board voted to hold Town Meeting on June
