 - Joe Stacy asked (via Facebook) if DEP had funding sources. Meisner responded no, the facility is a failing entity, but they are trying the best they can. Llamas added the facility cannot be shut down and the commission will address DEP issues as they request.

Business

- Julia Blyth: Open Space Committee Presentation of the 2019 Annual Citizen Stewardship Award to Jay Loubris
 - 2019 award presented to Jay Loubris by Blyth on behalf of the Open Space Committee.
 - Loubris teaches sixth grade science at Northfield Elementary and holds after school sessions for 20 weeks during the school year to fourth, fifth and sixth grade students. Students are taken on field trips pertaining to science.
 - Loubris thanked the parents, students and administration in Northfield and was honored to receive the award.
 - The Selectboard thanked Loubris for promoting the sciences and congratulated him on the award.
- O Chief Leighton: Body Worn Cameras
 - Request for the Selectboard to accept the policy for Body Worn Cameras
 - Policy is the same as Erving and Buckland with modifications for Northfield. Police union approved.
 - Technology for storage is currently on backorder. Once in place the officers would start using the cameras.
 - Officers not adhering to the policy will be dealt with case by case. There will be a learning curve.

- On a motion by Meisner, seconded by Jacque the board voted to accept Body Worn Cameras into the Town of Northfield Police Department policies and procedures.
- The Brewery at Four Star Farm license; approved by the state
 - On a motion by Meisner, seconded by Jacque the board voted to approve the Farmer Series Pouring Permit for The Brewery at Four Star Farm.
 - License signed.
- Signing of the bi-weekly warrants review
 - To reverse the change to a single signature during the early days of the pandemic back to majority signatures.
 - On a motion by Meisner, seconded by Jacque the voted to reverse the biweekly warrants review to a majority of the Selectboard.
- O Discussion on change of Selectboard meeting day to Tuesdays
 - Changing back to Tuesday avoids the problem of Monday holidays and signing of the warrant.
 - Meisner and Jacque agreed to Tuesdays. Llamas to ask Cummings if the switch works for him.
- Schedule hearing for 9/14 or 15/20 (pending discussion above) meeting for Cameron's Winery Change of Location liquor license application.
 - Motion by Meisner, seconded by Jacque the board voted to schedule the liquor license change of location for Cameron's Winery hearing for Monday September 14, 2020
- Sign letter RE: Main St. crosswalk signs to MassDOT Dir. Cavicchi, Sen. Comerford & Rep. Mark
 - Llamas added reference to the Complete Streets project which initially requested crosswalk improvements.
 - Letter to be posted on town website
 - On a motion by Meisner, seconded by Jacque the board voted to sign the letter for the Main Street crosswalk signs to MassDOT Director Peter Cavicchi, Senator Jo Comerford and Representative Paul Mark.
- Sign Letter RE: MassWorks grant for Warwick Rd.
 - Joint project with Warwick. Working with engineer.
 - Last year was submitted as separate projects from each town with no funding as a result
 - Senator Comerford helped by holding a conference call in support
 - The joint coordination will produce a stronger application
 - On a motion by Jacque, seconded by Meisner the board voted to approve the letter to Secretary Kennealy
 for the Mass Works Infrastructure Program for reconstruction of Warwick Rd. in Northfield
 Rd. in Warwick.
