Municipal Vulnerability/Hazardous Mitigation Plan

- Farrell and LaRose of the FRCOG presented the Community Resilience regional list of relevant hazards for Northfield and Warwick.
- The Executive Dept. of Energy & Affairs controls the MVP, MEMA controls HMP. The departments are combining to work with towns. Grants will be available.
- MVP focuses on climate change hazards with flexibility in emergency response; HMP is for any hazard and is more rigid.
- MVP takes a proactive, preventative approach; HMP reacts after the disaster.

(Pelletier joined at 4:30pm; Planning Board convened)

- LaRose defined high risk areas and asked the group to contribute climate related issues in the community.
- Topics: Shelters, seniors registering with TRIAD and outreach services, evacuation plans, ADA transition plans, renewable energy, generator upgrade.
- Creating MOU's with entities to include them in the discussion. Thomas Aquinas, Moody Center, the regions schools may have plans in place and could assist the community.
- Creation of a liaison committee to increase communication; hold drills to practice the plan

Environment

(Meisner joined at 4:50pm; Selectboard convened)

- The MVP could be used for engineering study and design.
- Sewer department needs major renovations to equipment and infrastructure. 280 users currently fund through sewer bills
- Proximity to the Connecticut River makes the plant vulnerable to flooding.
- Climate change issues contribute to over taxing the system
- Opening of Thomas Aguinas added significant increase of use
- Dam failure on the Connecticut River. Flood maps to be reviewed. Vernon Dam facility should be included in communications. Northfield Mount Hermon has an emergency action plan.
- Localized flooding issues; run off and failing culverts.
