 - Terms for Elected and Appointed Officials (to run July 1-June 30)
 - Elected Can only be changed by Special Act
 - Appointed Investigate the applicable term fixed by state law for each committees/board. Changing term of office may have the effect of shortening terms of office for some current officials and effectively "removes" them from office where their term may be fixed by law. Each board/committee must be reviewed and determine how to accomplish the task, so the terms remain appropriately staggered as provided by law.
 - Ad-hoc Committees Changing is allowed, they are created by a vote of the Selectboard and there is no appointment fixed by law
 - Appointed Committees Investigate the legislative underpinning of each body and determine whether the Town has the flexibility to change some may be able to be done by bylaw would have to include a "transition clause" for the changeover.

B: Town Facilities Open with Reduced Hours and Limited Capacity

When it is determined appropriate to do so, the Selectboard will vote to reopen Town Offices to the public for limited hours and by appointment. Staff when not in the building will continue to work remotely. Residents will still be encouraged to make appointments with Town employees.

- Safety protocols regarding PPE & Face Covering, Cleaning procedures, social distancing, etc. in place and in effect
- Sanitizing stations at each entrance as members of the public enter the buildings
- Restrooms limited to staff and people conducting official business
- All employees returned to their office. Employees who have documented underlying health conditions continue some hours present and some remotely.
- Public Meetings able to be held with Committee members present if social distancing can be observed. Guests and will continue to be encouraged to attend remotely if possible. Encourage to continue to use outdoor spaces or remote meeting as possible.
- Due to new orders and advisories from the Governor's Office, meeting with Police/Fire/EMS and Board of Health on Friday morning to discuss what they think as well. Update from FRCOG Health District indicates an increase in COVID cases in the county.
