- o 6:30pm-Dangerous Dog Hearing; Ewell
 - Hearing opened. Oath given to Keri Ewell

- Complainant Mark Rowe did not attend.
- Officer Dragon gave his report: Incident on 10/31/20 in which Mr. Rowe claimed to be attacked by Ewell's dog Mello. There was a previous incident on September 4, 2020 in which the same canine got into an altercation with Mr. Rowe's dog resulting in a minor injury to Mr. Rowe's dog. Rowe did not wish to pursue a hearing at that time. Notice of restraint was issued to Ewell.
- Ewell testimony: Dog was outside in area on property where Rowe's dog also comes into. Ewell heard a noise and noticed Mello looked startled. Mello went through the bushes, came back and was retrieved by Ewell and put inside. Ewell did not see what happened from where she was. She believed what Mr. Rowe reported did happen. Supplied written statements in support of Mello. In response Ewell has set up a fence on the Ewell/Rowe property lines stopping dogs from both parties from entering each other's property. Also installed a wireless dog fence. All dogs in the household have shock collars but were not in use at the time of this incident. Mello has never gone after anyone before. Usually friendly. Has not been aggressive previously. Fencing purchased Nov. 3. Receipts provided with photos of the 4' fence.
- Written supporting witness testimony from Steven Shearer, Kathryn Richard, Charles Dodge, Megan Sorensen who have had close interaction with Mello and have had no issues.
- Selectboard reviewed via internet the location of the property.
- Ewell considers herself a responsible dog owner. Mello neutered and licensed. Mello is 10 years old
- ACO Dragon September report: Ewell took full responsibility for incident and has spoken to Rowe.
- Wireless fence is in a circle about 70' from controlling device inside the house
- Ewell has owned Mello 9.5 years. Incident was out of the ordinary.
- Mello is either on leash or in a pen, shock collar when off leash.
- Ewell was outside when incident occurred. Mello about 15' from Ewell.
- Jacque concerned about 4' fence if it snows 2' dog getting over. Ewell did not feel it would be an issue
- Ewell accepted responsibility for training of the shock collars and wireless fence
- Wireless fence in operation on the property does not prevent dog from coming back once out of boundary
- Mello has gone to basic training. Mello goes on hikes with other people and dogs with no incidents. Ewell
 uses vocal and physical discipline
- The Selectboard was concerned by the multiple incidents. Dog has escalated. Restraint order violated. Selectboard was not comfortable not hearing from complainant Rowe.
- Ewell has not talked to Rowe since making changes after November incident
- Dragon did not see Mello in November.
- Ewell added Mello was a good dog and was not sure what changed, if it was related to being home more due to COVID or stress but in general not a nuisance or dangerous dog
- Dogs are not on insurance, Ewell rents property. Dragon not sure if insurance available for renters
- Mello last vet visit for yearly physical or leg injury. Mello is a mixed breed not a German shepherd as in the report. Jacque recommended checking Mello's thyroid and eyesight given his age for changes which may contribute to behavior
- Testimony concluded. Motion by Meisner, seconded by Jacque to close the dog hearing at 6:59 pm
- Deliberation:
 - Cummings: Lack of complainant testimony. Steps taken to secure were a good reflection of the situation. Significant measures taken.
 - Meisner: Muzzle not necessary. Taken immediate precautions. When home make sure leashed and utilize fencing. Not dangerous dog. Prepare order to leash, fence and formal written warning
 - Jacque: like to know if actions taken are acceptable to neighbor. Uncomfortable with September incident if restrained this would not have happened. Dog is traversing boundary. Agree with restraint. Concern for future, how much weight does written warning have.

- Dragon: If not declaring dangerous declare nuisance. Give orders to alleviate issue.
 Follow process if not followed.
- Meisner: doesn't see dog as nuisance. Wake up call for Ewell to take precautions.
- Jacque: fence is not an enclosure. Dog has left yard twice. Neighbor concerned about 4yrold grandson. Documentation shows escalation.
- Meisner: asked if there can be an evaluation prepared by professional.
- Dragon: recommends since there is no testimony from the complainant, the option since the dog has twice caused a disturbance, declare the dog a nuisance and order to restrain
- Jacque: we are on record we don't want to see any more violations. Agrees with Dragon not to
 declare dangerous without complainant testimony. Agreed with issuing determination with
 restraint and on leash continues according to law that exists. Recognized steps have been taken
 to enhance the restraint to keep the dog in the yard. Add supervision when dog outside.
- Dragon: if there is a violation, process follows the same as the process for a dangerous dog.
- Summary: Leash, fence, direct supervision, declare nuisance
- Motion by Meisner, seconded by Cummings the board voted to declare Carmello, Northfield tag number 2020-158 who resides at 759 Pine Meadow Rd to be declared a nuisance animal with orders of leashing at all times, fencing and to have direct ownership supervision while outside.

 - Gary Clark, along with his siblings own the property across the street from the Matosky property, have concerns about the number of vehicles and claimed Matosky is in violation of state code of 600' of any state highway. Concerned about brown water.
 - License granted in 1976 does not indicate mandatory testing.
 - Clark would like to see limitation of number of cars. Jon MacDougal requested looking into ecological restraints. Request to investigate alterations of the lot if 100 vehicles were on the site.
 - Meisner to contact Matosky, have him come in and do an investigation.
 - Motion by Cummings, seconded by Jacque the board voted to withdraw the vote on the license at this time.
 - Summary: Review of the original permit; EPA groundwater testing; stipulation the site is too close to the highway; the amount of vehicles permitted by the square footage of the lot; insuring the fencing regulation as been upheld and check for grandfathering clause due to the age of the permit.

 - The Selectboard to review list of possible regulations and get back to Llamas. Llamas to confer with Highway, Police and Fire departments for possible conflicts. Resident input requested.
