ANNUAL MEETING



To Teresa Nelson, clerk of the Northfield Water District, Northfield, Mass., in the county of Franklin.

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify the inhabitants of the territory included within the Northfield Water District qualified to vote in District affairs to meet at the NORTHFIELD TOWN HALL in said Northfield on March 23, 2023, at 7:00 P.M. to act upon the following articles:

ARTICLE 1: To choose a moderator to preside at said meeting.

ARTICLE 2: To elect one water commissioner for three years; a clerk, a treasurer, a collector, and a meter reader to serve until the next succeeding annual meeting.

ARTICLE 3: To see what sum or sums of the money the District will vote and appropriate for salaries for the commissioners, treasurer, clerk, collector and meter reader or take any vote or votes in relation there.

ARTICLE 4: To see what sum or sums of money the District will vote and appropriate to bond its treasurer, to insure its property, and to purchase liability insurance to cover officers of the district, or take any vote or votes in relation thereto.

ARTICLE 5: To see what sum or sums of money the District will vote and appropriate for maintenance and operation of its water system or take any vote or votes in relation thereto.

ARTICLE 6: To see what sum or sums of money the District will vote and appropriate for administrative expenses, including office supplies, telephone, clerical services, or take any vote or votes in relation thereto.

ARTICLE 7: To see if the District will vote to authorize the treasurer, with the approval of the water commissioners, to borrow money in anticipation of the revenue of the current fiscal year, or take any vote or votes in relation thereto.

ARTICLE 8: To see if the District will vote to authorize the water commissioners to defend any suit or suits acting as its agents that may be brought against the District or engage counsel, and to bring suit on behalf of the District which they may deem advisable, and to appropriate a sum of money therefore or take any vote or votes in relation thereto.

ARTICLE 9: To see what sum or sums of money the District will vote and appropriate to cover legal expenses of the District, or take any vote or votes in relation thereto.

ARTICLE 10: To see if the District will vote to appropriate a sum of money to pay bond and interest on loan

ARTICLE 11: To see if the District will appropriate a sum of money to match the Social Security and Medicare payments by its elected official

ARTICLE 12: To see what sum or sums of money the District will vote and appropriate to Replace Piping within the Pump House, and any additional money as needed.


ARTICLE 13: To hear reports of the officers of the District and act thereon.


ARTICLE 14: To hear any other business that may come before the meeting and act thereon.
