

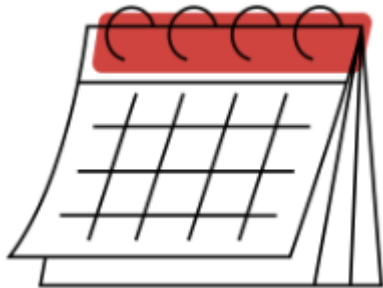

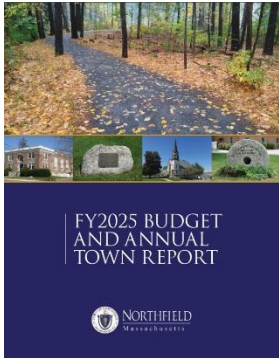

Spring Has Sprung!

Spring is here, and with it: Town Meeting and Town Election season! Northfield bylaw mandates that Annual Town Meeting takes place on the first Monday in May. This year, that makes it almost the latest it can possibly be, on Monday, May 6th. Town Meeting will be held at the Pioneer Valley High School at 7:00 PM. The warrant and the motion warrant are posted on the Town's website at: <https://www.northfieldma.gov/home/news/town-election-town-report-town-meeting>.



At that link is also the Town's new Budget Book/Town Report – which has a lot of information, including department reports followed by a breakdown of each department's individual budget by line item. I urge you to take a look at this new format, as Town departments put in a lot of work to detail their mission, describe the work of their department and outline their accomplishments from this year and their goals for next year. We moved to this expanded format in the hope that it would provide more useful and interesting information for town residents, and allow them to see the relationship between the department's responsibilities, goals and budget. I want to thank all the Town departments for their cooperation in this new project – I think the results speak for themselves!

I hope that you will join myself and Town officials at the Annual Town Meeting on May 6th to ask questions, learn more about the town's finances and operations, and vote for the next fiscal year budget.

News from the Town Clerk's Office

- **Town Meeting is Monday, May 6th at Pioneer Valley Regional School at 7:00 p.m.**
- **Town Election is Tuesday, May 7th at Town Hall from 12 p.m. to 8 p.m.**

Northfield's Annual Town Meeting is held on the first Monday in May with the Town Election the following Tuesday. Candidates are nominated at the Non-partisan Caucus in March. Most elected positions are for a three-year term, and a list of offices up for reelection can be found on the town website under the Town Clerk's page. Candidates are nominated for each office on the ballot, and can speak or send someone on their behalf.



All registered voters were sent a Vote by Mail postcard application at the beginning of the year. If you selected "All Elections" you will receive a ballot for all elections in 2024 including our local election. **The State will be mailing a second round of postcard applications for the September Primary and November General Election for anyone who has not already signed up.** You can always check your application status, apply for a ballot, register to vote/check your voter registration status at <https://www.sec.state.ma.us/OVR/>.

Transfer Station stickers and dog registrations can be purchased online at <https://unipaygold.unibank.com/customerinfo.aspx>. Make sure to provide a copy of your dog's current rabies vaccination. If you received a letter stating your dog's registration is past due and you are no longer a dog owner, please let us know so we can remove you from our list.

Series: Tips On Navigating the Town Website

In each newsletter, we'll be sharing tips on how to navigate the town website. At www.NorthfieldMA.gov, you'll find plenty of important information and resources.

This issue, we would like to let Town residents know that there is a new option added to the online payment system through the Treasurer's Office, called Bill Presentment.

UNIPAY

Northfield residents have the convenience of online payments through UniPay, where they can schedule payments, save payment information, view payment history, and set up payment reminders. Best of all, you can now download your bill and go paperless!

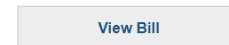
To pay your taxes have your bill and checkbook or credit card in hand, and then...

UniBank, our banking partner, will charge a nominal processing fee for credit card payments. A fee schedule is located on the welcome page for your convenience. Use your checking account and there will be a 50¢ fee.

Updates from the Assessor's Office

Cyclical inspections starting in May: The Board of Assessors has retained contracted services with **Mayflower Valuation, LTD** to assist us with cyclical inspections. We do 100 cyclical inspections a year to be in compliance with the Massachusetts Department of Revenue directives. Letters were mailed out to those property owners who are subject to a property inspection. The letter includes the inspectors name as well as the vehicle they will be driving (including make, model, color, year, and License plate number).



The purpose of the cyclical inspection is to verify the data in which the assessed values are in part based. Since soundly based equitable assessments require accurate property data, we ask for your cooperation. Our inspector will have a copy of your property record card on hand and will review it while on your property and may ask you questions to confirm accuracy of the card. The inspector will also measure your dwelling and any additional structures on your property. Your property record card will get updated accordingly. A photo may be taken of your dwelling if the one on file is outdated. **Again, only those who receive the letter from our office will have this inspection.** Any questions or concerns, please contact the Board of Assessors Office.

A Note from the Sewer Collector

You should have received your second half FY24 Sewer bill which is due **May 15, 2024**. If you have not, please reach out to Michele (contact info below) for a copy. Don't forget we have an added convenience feature that allows you to pay your bill online. Follow the links to Pay Bills at www.northfieldma.gov. See "Series: Tips On Navigating the Town Website" earlier in this newsletter for a guide!

Pay your bill on time to avoid receiving a Demand Bill that includes a \$5 demand fee plus interest.

You may have already heard that we are switching to **quarterly billing** in FY25. The due dates will be as follows:



- 1st quarter: due August 15, 2024
- 2nd quarter: due November 15, 2024
- 3rd quarter: due February 15, 2025
- 4th quarter: due May 15, 2025

These due dates will be consistent unless of course there was to be a problem getting the bills issued. In that case the due date will be 45 days from the date of issue. Should the due date fall on a weekend the payment will be accepted the following Monday. Michele has limited hours at the Town Hall – Monday and Wednesday 9:00 a.m. to 4:00 p.m., so please plan accordingly.

The quarterly billing system should allow you to better budget and plan how you choose to pay for your Sewer Use charges. Michele does have customers that make monthly payments, and is happy to accommodate those. For those of you who may prefer to pay in advance you are also welcome to do that. Please note that any amounts owed after the due dates will accrue interest and all amounts outstanding after the 4th quarter due date will be charged interest and a demand fee. Thank you!

Updates from the Grant Development Director

Funding requests submitted in March and April included:

- A request for Congressionally-directed spending, to fund \$5 million of the remaining funds needed for the Pauchaug-Schell Bridge reconstruction. We may not hear back until spring 2025, unfortunately...
- A grant application submitted to the Municipal Vulnerability Preparedness Action Grant program, to fund repairs and upgrades to the Dickinson Street Sewer Sub-Area. Grant awardees will be notified in summer 2024 and Leslie will provide an update in the Town newsletter if we receive the funds.



Results from the Economic Development Community Survey (which concluded in January 2024) are in!

Important figures include:

- Roughly 5% of Town residents completed the survey
- 82% of respondents think that **outdoor recreation** should be highlighted or pursued, to attract visitors
- Respondents do want to see business development, commercial activity, and tourist/visitor activity **increase in Northfield** – however, most would like this activity to occur **away from their homes**
- 92% of respondents feel that **renovation and redevelopment of existing buildings** is the best strategy for accommodating new businesses in Northfield
- Many people want to see a more **“vibrant” Main Street** – but believe that new development should be aligned with Northfield’s **“small-town” feel**

Survey results will be used to guide economic development initiatives, grant opportunities, and future community engagement opportunities. For more information, please contact Leslie at grantdevelopmentdirector@northfieldma.gov.



There is a **Listening Session** on **Wednesday, May 1st at 6:00 p.m.** in the **Select Board meeting room** to discuss the Business Park Feasibility Study, completed by consultants at Westmass Development. This was funded by a Community Planning Grant secured by Mallory from the Executive Office of Housing and

Economic Development. Sean O'Donnell and Sarah LaCour will present on the study and take questions and comments from Town residents. Please join us!

Bulky Waste Recycling Day

The Franklin County Solid Waste Management District is collecting the Spring “Clean Sweep” Bulky Waste Recycling Day on **Saturday, May 11th** from 9:00 a.m. to 12:00 p.m. The three drop-off sites are: Erving Senior Center at 1 Care Dr (off Rt. 63) (*note new site instead of Northfield Highway Garage*); Mohawk Trail Regional School at 26 Ashfield Rd. (Route 112 South); and Whately Transfer Station at 73 Christian Lane.

Residents from any of the District's 21 member towns may bring bulky items such as tires, appliances, scrap metal, furniture, carpeting, construction debris, computers, televisions, propane gas tanks, and other large items. Materials will be recycled whenever possible. For more information about the event and what will be accepted, visit franklincountywastedistrict.org. **Mattresses and box springs will not be accepted at this event;** visit franklincountywastedistrict.org/mattress-recycling for more information about mattress recycling locations across Franklin County.

There are charges for most items. Disposal fees, cash only, will be collected during check-in at each site. A complete list of prices for the most common items is at: franklincountywastedistrict.org. The price list will also be provided to participating town halls and transfer stations. Residents and businesses do not need to pre-register for the collection.

Veterans' Services on the Fourth Tuesday

The Upper Pioneer Valley Veterans' Service District advocates for veterans and their spouses, dependents, widows, or widowers for veterans' benefits at the local, state and federal levels. They assist veterans in filing for benefits like burial or death benefits, VA healthcare, property tax exemptions, military records, and more.

They also provide referrals for issues regarding homelessness, health, education, and employment; archival of discharges; discharge upgrade requests; and SHINE counselor assistance, which provides free health insurance information and counseling.

District Veterans' Services comes to Northfield Senior Center (in the Town Hall) every fourth Tuesday of the month from **9 to 11 a.m. (May 28th, and June 5th)**.
