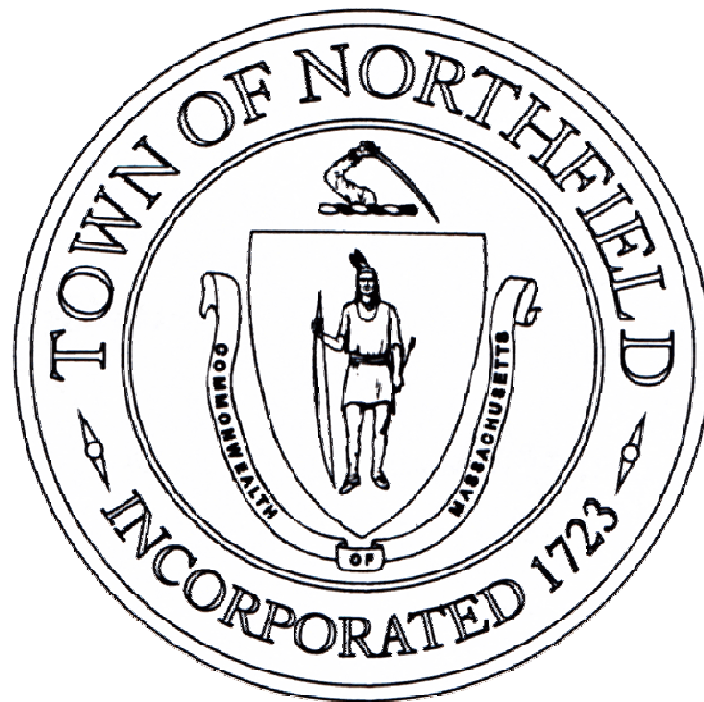

To any of the Constables in the Town of Northfield, in the County of Franklin,

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of the Town of Northfield, qualified to vote in elections and in Town affairs, to meet at the

Pioneer Valley Regional School

in said Town on Monday, May 3, 2010 at seven o'clock in the evening (7:00 p.m.), then and there to act on the following:

Article 1. (Submitted by the Selectboard)

To see if the Town will vote to waive the reading of the Warrant and the Notice to the Constables and act on the motions of the following articles, or pass any vote or votes in relation thereto.

Article 2. (Submitted by the Selectboard)

To see if the Town will vote to transfer a sum of money from Free Cash for Fiscal Year 2010 salaries for the Police Department, or pass any vote or votes in relation thereto.

Estimated amount requested *\$4,000.00*

Article 3. (Submitted by the Selectboard)

To see if the Town will vote to transfer a sum of money from Free Cash to pay a stipend due to a registrar from a prior year, or pass any vote or votes in relation thereto.

Estimated amount requested *\$150.00*

Article 4. (Submitted by the Council on Aging)

To see if the Town will vote to transfer a sum of money from the Senior Center Design Account for construction of a pavilion behind Town Hall, or pass any vote or votes in relation thereto.

Estimated amount requested *\$20,000.00*

Article 5. (Submitted by the Board of Library Trustees)

To see if the Town will vote to transfer a sum of money from Free Cash to restore documents held at the Dickinson Memorial Library, or pass any vote or votes in relation thereto.

Estimated amount requested *\$1,000.00*

Article 6. (Submitted by the Board of Library Trustees)

To see if the Town will vote to transfer a sum of money from the Library Building Project Account to the Library Energy Savings Measures Account for use in the installation of energy efficient lighting at the Dickinson Memorial Library, or pass any vote or votes in relation thereto.

Estimated amount requested \$2,250.00

And you are directed to serve this Warrant by posting up attested copies thereof at the Town Hall; the U.S. Post Office in Northfield; the Dickinson Memorial Library; the Field Library, Northfield Farms and the V.F.W., West Northfield, in said Town fourteen days at least before holding said meeting.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.
